QUARTERLY COMMENTARY Jul-Sep 2020

In a falling UK equity market, it is good to see a small positive in the YT20 portfolio. Stock selection remains our raison d'être given our limit of 20 positions.

York based Gear4Music continued to demonstrate their rapid growth profile in the musical instrument market. Their initiatives in digital media and musical instrument refurbishment over the coming years have the potential to maintain their growth profile and surprise the financial markets.


Avacta, based in Wetherby, has increased its dialogue with the government Condor team on their rapid COVID-19 testing solution. Q4, 2020 is expected to be an active period for the company as we discover if dialogue can be converted into sales and profits. Beyond this short time frame, their therapeutics division continues to develop the next generation of cancer therapies aimed at tumour targeted chemotherapy.

On the negative side, the supermarket WM Morrison's, based in Bradford, disappointed over the quarter from a share price perspective. Their announcement of a delivery agreement with Amazon, testing in the Leeds area, however, is potentially a transformational deal.

New holdings include the aquaculture firm Benchmark Group, based in Sheffield. The company was added to the portfolio following meetings with the new management team, who have reshaped the group, disposing of several non-core businesses. We are now watching the salmon and shrimp industry with significantly more interest.
